

2022-2023 ANNUAL REPORT

This year the Bainbridge Schools Foundation awarded more than \$600,000 to the Bainbridge Island School District thanks to our generous donors and sponsors who honored their commitment to our public schools! We extend our sincerest gratitude for your generous contribution. We do not take for granted the strength of our community who partner with us to provide the best education for our students – our future generation of thinkers, creators, and innovators. As you well know, state and federal funding are insufficient in meeting the expenses of basic education, and the Bainbridge Schools Foundation mission to bridge the gap is imperative to the success of our public schools. Thank you for joining us in this critical mission.

With your help, Bainbridge Schools Foundation is able to extend support where it is needed most. We are proud of this community for coming together to ensure our students receive the rich educational experience they deserve. This year we provided more than \$55,000 for K-12 academic support materials, and \$12,000 for educator professional development to promote recruitment and retention. In addition, BSF funded over \$500,000 dollars in certificated staffing districtwide to actively staff K-12 academic intervention programs, innovative programming, and new educator support. Without BSF's contributions, there would be less support available to all students and educators. Together we make the biggest difference.

Looking ahead, the generosity of our community continues to propel innovation, equity, and support for 3,423 students and 261 certificated educators on our island. Since 2020, we have seen students struggling with learning loss, pandemic stress, and many forms of readjustment academically, socially, and emotionally. In our direct and collaborative work with the Bainbridge Island School District and in listening to the concerns within our donor community, we heard your prioritization of the social emotional learning and health of the entire public school community. With your continued support, the Bainbridge Schools Foundation is excited to announce that it has pledged nearly \$200,000 for the upcoming 2023-2024 school year to support the acquisition and adoption of the district's new social emotional learning curriculum, Character Strong.

We are honored to support the district's adoption of this critical curriculum, reaching kids where they are with the tools needed to thrive as students and citizens. As a community and foundation, we have been able to fund innovative programming,

additional curriculum components, and resources otherwise unavailable through state and federal funding. Most significantly, our collective investment in comprehensive mental health support for our students will create a safer learning environment, and allow for the education of our students to continue more mindfully and more effectively.

Thank you for prioritizing our mission with your time, resources, and trust in our work to support the students and educators of Bainbridge Island School District! Our mission would be impossible without your continued support, whether through donations, volunteer efforts, or spreading the word about our cause. Every contribution, no matter the size, makes a significant difference in the lives of our students and helps us in achieving our goals. 
